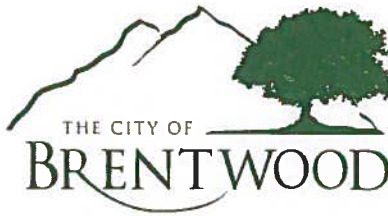

1. **You must qualify under the income and first time homebuyer guidelines, including but not limited to the following:**
  - a. Fall within the income range for low income households based on household size (see attached income guidelines).
  - b. Have not owned a home for the last 3 years.
2. Confirm your eligibility by completing the First Time Homebuyer Program survey (page 1). Should you have any questions about your eligibility, please contact the Housing Division at (925) 516-5405.
3. Complete the requested employment, income and household size information on the application form (page 2).
4. Certify your eligibility by reading and signing the statements on page 3.
5. Return your completed application to the address below. The first 100 applications will be accepted on a first-come basis, after which the waitlist will close until further notice.

- Yes! Are you currently employed full-time?**
- Yes! Are you able to contribute the required amount of \$4,000 (minimum) personal savings? (Must currently have minimum in savings account)**
- Yes! Do you meet the income guidelines based on family size? (See the attached Income Guidelines)**
