



RESIDENTIAL STREET ADDRESSING APPLICATION

PROCEDURE:

1. One copy of the completed application.
2. The processing fee.
3. Two copies of the subdivision map showing all lots with their corresponding lot numbers and all streets with their corresponding street names. Said submittal shall include a numeric lot number list with the corresponding street name (see the attached example).
4. The submitted map size must be in either an 8 ½" x 11" or 11" x 14" format. Any map larger than this format will not be accepted.
5. One CD-RW disk containing the completed addressing worksheet in Excel format. A template may be obtained via e-mail by contacting the City of Brentwood Community Development Department at jjzilm@ci.brentwood.ca.us (Jeff Zilm) or created by the applicant following the attached sample.
